

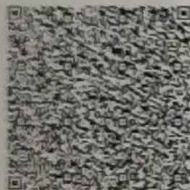

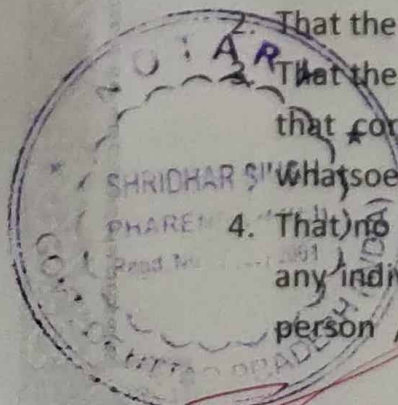

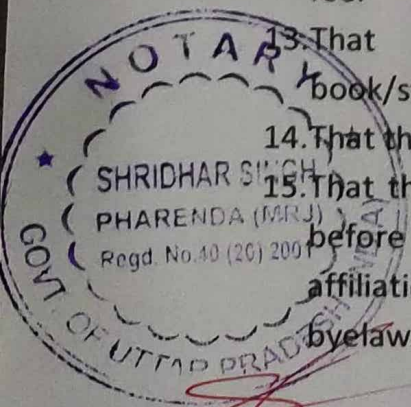
1. That the Kaushik Shiksha Avam Seva Trust is a registered under the 1860 Act.

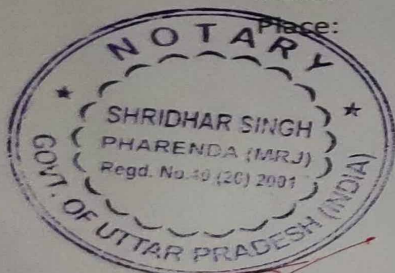
